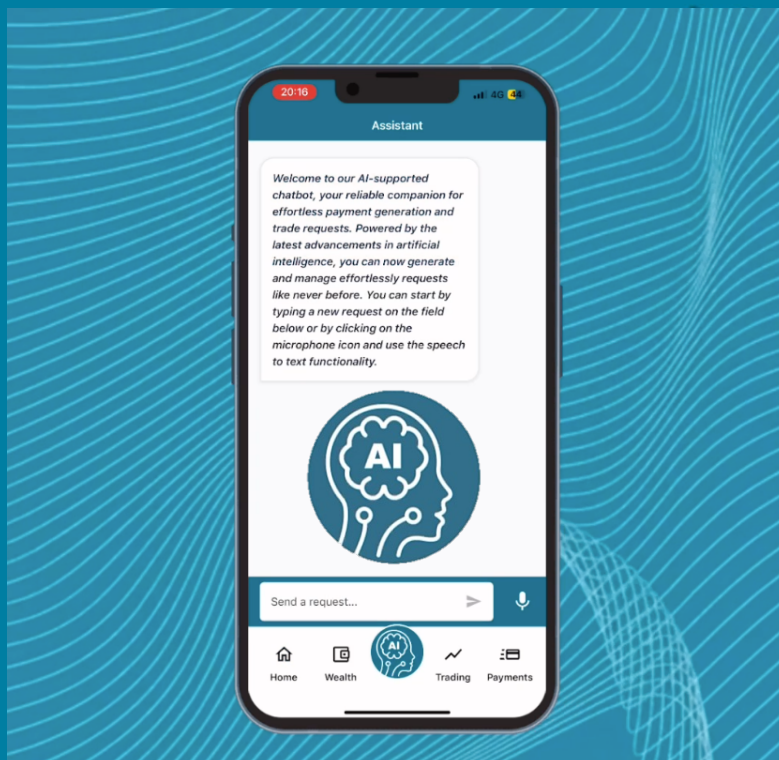

Our Mobile Banking Application offers an innovative and convenient way to manage your finances anywhere and anytime.

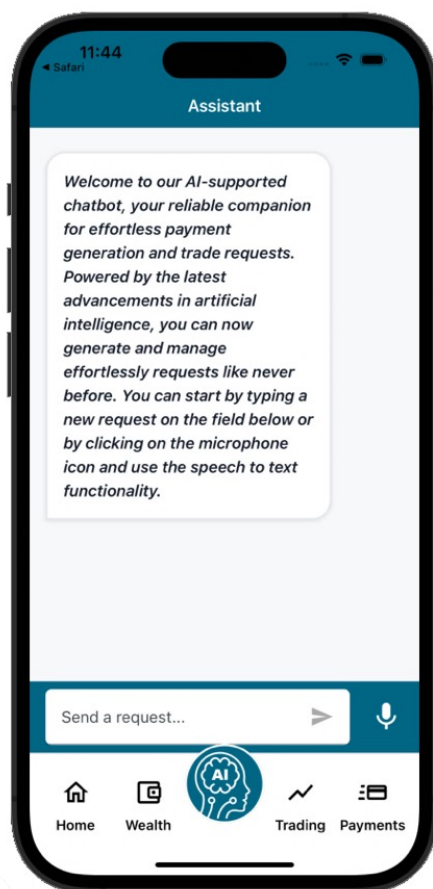

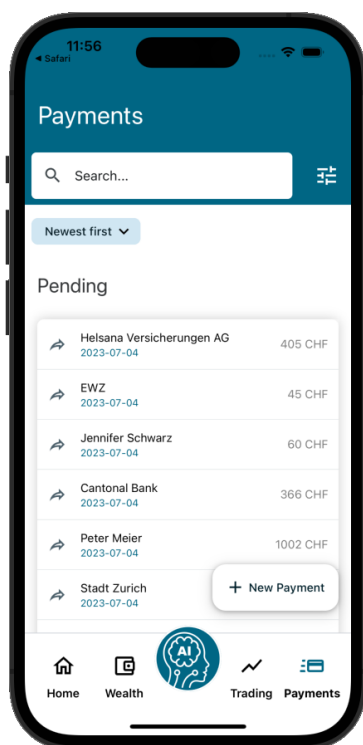
Advanced Order Durations

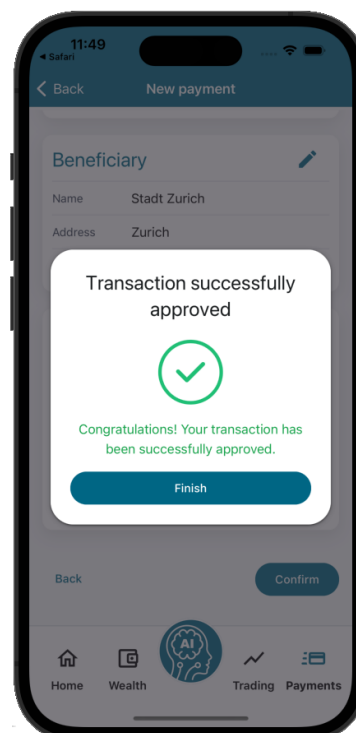
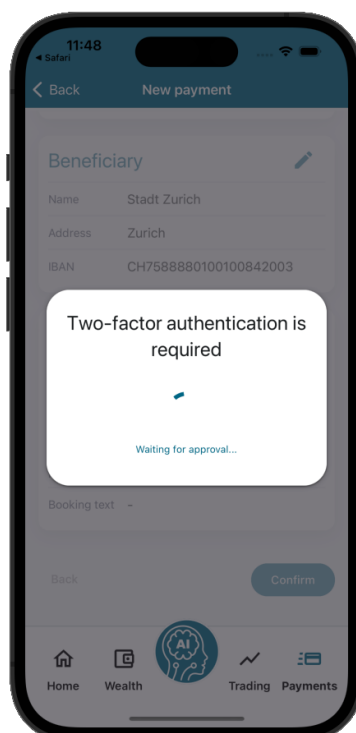

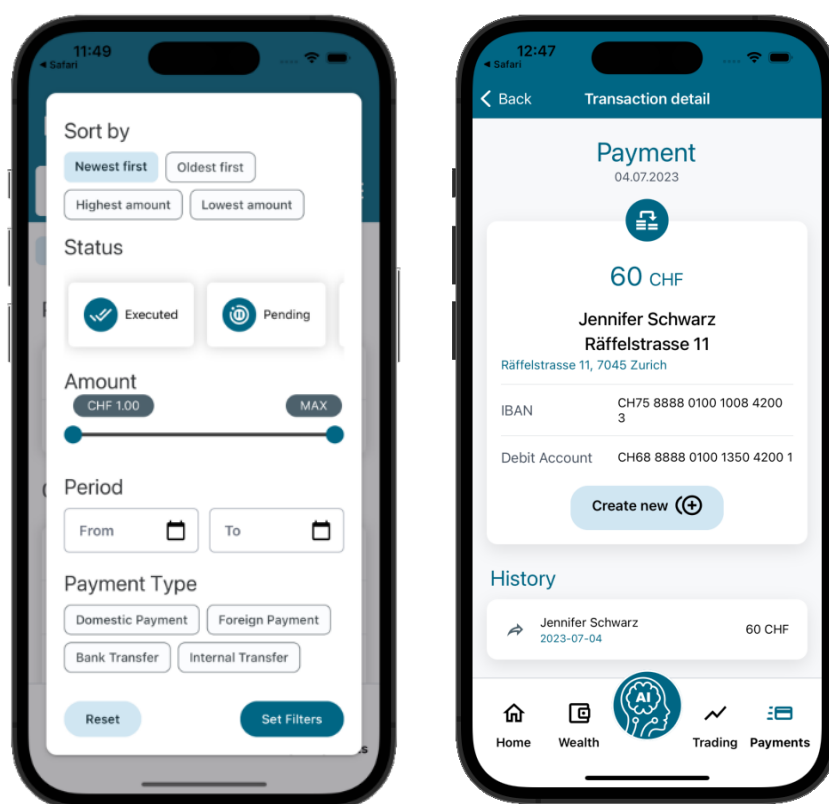


Additional Sorting and Filter Methods
